Kiosk Rehabilitation and Invasive Plants Species Education.

My name is Katie Keating and I am a Senior Girl Scout with Troop 1140 in Falls Church, Virginia. I was looking for a project for my Gold Award when I was lucky enough to meet Mr. Ted Welch and Mr. Philip Latasa with the Friends of Accotink Creek. After meeting with Mr. Welch we decided a good project was to rehabilitate the vandalized kiosk located in Wakefield Park. There are several reasons why I chose to pursue this project. The first is that I have always been a nature lover and I relished the chance to provide education about the dangers invasive plants cause our local environment. I did not realize until I started research for this project that invasive plant species are the second most serious threat to natural areas and the native plants and wildlife that live there. The problem caused by these plants does not stay contained to the local areas but can affect marine life hundreds of miles away in the Chesapeake Bay. I was also drawn to this project because I believed the rebuilding of this kiosk would upgrade the park and cause people to take even more pride in this beautiful haven. I also thought that due to the volume of traffic, in the form of hikers and cyclists that pass along the trail this location gives me an excellent opportunity to educate people about invasive plant species.


